The 2025 MAFWA Private Lands Working Group Meeting was held February 11-13, 2025 at the Monroe County Convention Center & affiliated Courtyard By Marriott in Bloomington, IN. Private Lands, Public Lands and Wildlife Diversity Working Groups began at 9:00 am on the 11th, and concluded at 12:00 pm on the 13th.

The 2025 joint Private Lands, Public Lands, & Wildlife Diversity Technical Working Groups convened from Feb.11-13 of 2025. Each group participated in a joint morning session of presentations on Feb. 11, before concentrating on breakout groups focused on each committees efforts in the afternoon of the 11th and morning of the 13th. February 12th consisted of a joint working group field trip to visit various relevant conservation efforts in Indiana.

The 2025 Private Lands Working Group Committee Meeting concentrated on identifying the greatest successes, opportunities, and challenges of each state's private lands program (see attached state reports). The Private Lands Technical Working Group Meeting began with a presentation by John Morgan from the National Grasslands Conservation Initiative (NBGI), who provided information on the Collaborative Conservation Initiative efforts and updates on RCPP AFAs managed by NBGI. From there, a group discussion occurred regarding Farm Bill funding and timing/challenges associated with federal funding at present. Afterwards, each state provided a presentation about successes, challenges, and opportunities in their state reports (attached). The last item of business included a robust discussion about a private lands training center or training framework. Detailed discussions occurred on this topic on both the afternoon of the 11th and the morning of the 13th. This last topic (private lands specific training) was in line with discussions from the 2023 and 2024 Private Lands Working Group meetings.

There were 20 attendees to the Private Lands Working Group Meeting From 8 of the 13 MAFWA states.

Overview

Any "successful" private lands program requires a foundation based upon *Funding, Relationships*, *Communication, Technical Assistance & Flexibility*. Agency administrators, landowners, conservation partners & stakeholders are critical components for such programs. All aforementioned components are required to facilitate the ability of a private lands program to successfully foster relationships with private landowners. Availability & consistency in funding & staffing are critical for private land conservation. Moreover, effective communication & the ability to meet landowners "where they are" provides the flexibility & skills necessary to implement conservation programs. Current struggles with secured funding & staffing create the greatest challenges facing private lands conservation throughout the Midwest Association Of Fish & Wildlife Agencies (MAFWA).

Program Successes & Challenges Successes

While each agency experiences struggles, they also experience successes. Common successes include dedicated & passionate staff & strong partnerships with passionate landowners, all working to address conservation needs & combat difficult resource threats. Each agency has customers who are knocking on their door, seeking technical assistance & asking for guidance & participation in myriad conservation programs. Such successes were highlighted during our recent technical working group meeting from each attending agency representative. These successes had common themes of reliance on Wildlife & Sport Fish Restoration (WSFR) funds, Farm Bill funds, Inflation Reduction Act (IRA) funds & the unique expertise of trained, knowledgeable staff. Common themes of interest in habitat development programs, recreational access programs, an onus on the importance of agency private lands programming, uncertainty with the future of federal funding & the need for unique training for private lands staffing were all identified & discussed. **Challenges**

The 2 most common challenges identified by this working group included the uncertainty of federal funding & the need for specific training of new staff. Detailed discussion about Farm Bill technicalities & issues is common at these meetings. Such discussion didn't occur at this meeting due to pauses in federal funding & the uncertain future of the next Farm Bill. Much discussion occurred about "big picture" federal funding & impacts due to challenges with Farm Bill, WSFR & IRA pauses in funding. The MAFWA Agriculture Policy Program Manager provided a status update related to Farm Bill & IRA monies, as well as briefing the group about the upcoming "Farm Bill Fly In".

Training for staffing, recruitment/retention of staff & needs for a private lands training framework were discussed. A decision was made to delay any action item request for this topic until AFWA advances a similar national initiative relative to a Private Lands Stewardship Academy. Upon development of that, an "Action Item" request may be submitted to support & fund the AFWA based training academy & any enhancements or further training items necessary specific to MAFWA. To prepare for such a request, this working group identified regionally based training needs (attached).

Future Needs

This working group stands ready to provide input into any new Farm Bill proposals. The working group also is prepared to cater regionally based training needs of new staff.
